

Nevada Union High School Telecommunications Academy Tablet Usage Contract

The tablet computer is made available for authorized use to students enrolled in the Telecommunications Partnership Academy in Grades 10, 11 and 12 at Nevada Union High School. Students are responsible for the safe, appropriate operation and care of the tablet computer. Expectations for the use of the tablet computer and care of the tablet package (defined herein as tablet computer, power cord charger and sleeve) are as follows:

1. The tablet computer is for educational purposes;
2. The student can only install software listed on the school approved software list on the technology service page;
3. Only the assigned student will operate the tablet package. The student will not give his/her password to any other person. The student is ultimately responsible for all material accessed and/or transmitted;
4. When the student takes the tablet home, he/she will charge the tablet computer that night and must bring the charged tablet back to school the next day;
5. The tablet may not be removed from its case;
6. The student must immediately report to their teacher any mechanical problems with the tablet package. No attempt should be made to repair the tablet;
7. The student and parents/guardians accept full responsibility for the return of the tablet package in good condition at the end of the school year:
 - a. If any part of the tablet package is stolen or lost, the student or parent/guardian should immediately notify their teacher;
 - b. Willful and/or malicious damage to any part of the tablet package will result in a cancellation of privileges, disciplinary action and/or reimbursement for repairs and/or replacement cost of the tablet computer, the charger or the case. Damage includes, but is not limited to, physical damage and/or unauthorized alterations to the tablet, attempts to destroy data of other users or the network, and the uploading or creation of computer viruses.
 - c. The student and parent/guardian will be held financially liable for loss or theft of the tablet package while not in school. Tablets must be check into a partnership teacher immediately after school for secure storage if the tablet is to be left at school overnight. Students in afterschool activities should keep the tablets in their locked locker. The replacement cost of the tablet package is \$400. All financial obligations must be taken care of prior to the end of the school year. Failure to discharge any financial obligation may result in a hold being placed upon report cards, transcripts, diplomas, or the transfer of records.
8. Parent/guardian will monitor use of the tablet package, including E-mail and Internet privileges outside of the school hours;
9. The Nevada Joint Union High School District 9-12 Student Instructional Technology Acceptable Use and Internet Safety Policy is attached and is part of this Usage Contract. Both documents must be reviewed by parents with students with verified signatures;
10. Consequences for failure to abide by the terms of the contract (inappropriate use) will include one or more of the following:
 - Parents will be contacted.

- Meet with Principal/Assistant Principal
- Detention
- Loss of use of tablet at home
- Conference with parents and grade level team
- Loss of use of tablet at school
- Suspension
- Expulsion

The student and parent's signatures will indicate acceptance of the terms of this contract and their agreement to abide by all the rules in The Nevada Joint Union High School District 9-12 Student Instructional Technology Acceptable Use and Internet Safety Policy. The signature also acknowledges receipt of the "Acceptable Use Policy."
